



KMVK OFFICE RUSH CONTEST RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER THE OFFICE OF THE DAY CONTEST

- a. The MOViN 107.5 Office Rush Contest will begin Monday, January 7, 2008, and will run until Sunday, March 30, 2008, between the hours of 7am CST and 6pm CST. (the "Office Rush Dates").

All Valid entries must include office name, office address, office city, contestant's name, contestant's phone number, and contestant's valid email address.

- b. Once a week throughout the Contest Dates, one (1) winner will be selected each day between the hours of 10am CST and 12pm CST. Pending verification of eligibility, the announced name of the Office Rush contest will be that week's winner. After the winner's name and office are announced, the winner will be required to provide all information requested, including their full name, complete address, including Zip Code, daytime and evening phone numbers, valid email address, and their date of birth to be eligible to win.
- c. There is no limit to the number of times a listener can enter to win. A listener may only win once during the promotion, and only one winner per household / office can win during the run of the promotion. For this Contest only, restrictions that would prevent a listener from winning if he/she had won another recent CBS radio station contest or sweepstakes will not apply.
- d. Neither the participating stations nor their licensees, corporate parents, CBS Radio Corporation, nor their affiliated entities (collectively, "CBS Radio") will be responsible for telephone service outages, delays, interruptions, busy signals, equipment malfunctions and any other technical difficulties or for any medical emergencies which may interrupt or prevent completion of a telephone call.

2. ELIGIBILITY RESTRICTIONS:

- a. The Contest is open to legal residents of the Dallas / Fort Worth Metropolitan who are 21 years of age or older. Contestants will be entered in to a database and drawn randomly. Employees of KMVK, its corporate affiliates, CBS Radio KMVK-FM, Inc., affiliated entities, affiliated advertising agencies, participating sponsor/promotional partners including,

but not limited to sponsors' employees and their immediate families (parents, children, siblings, spouses) or persons living in the same households as such persons, whether related or not, are ineligible to participate.

3. PRIZES:

- a. Office Rush Prizes: Each Prize is an office lunch for up to ten (10) employees on the winning office provided by the Office Rush lunch sponsor. All taxes, including but not limited to, federal, state, and local taxes, and any other costs and expenses associated with the acceptance and use of a prize are solely the responsibility of the winner. Prize cannot be transferred, substituted or redeemed for cash except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize, or portions thereof, with a prize of equal or greater value, at its sole discretion. All prizes are awarded "AS IS" and WITHOUT WARRANTY OF ANY KIND, express or implied, (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose) by Sponsor.
- b. Pending verification of each winner's eligibility, prizes will be shipped directly to each winner's office address, as supplied by the winner, unless other arrangements are made. Any prize not claimed within thirty (30) days of winning will be forfeited by the winner.

4. WINNER SELECTION AND NOTIFICATION:

- a. Decisions of CBS Radio with respect to the Contest are final.
- b. Potential winners will be determined as described in Section 1(b) above and will be notified by telephone at the time of their calls.
- c. Contestants will enter themselves into the contest at <http://MOViNdfw.com> and be randomly drawn.
- d. Odds of winning depend upon the number of entries.
- e. Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within fourteen (14) days of winning. If winner is under the age of majority in his/her state of residence (a "minor"), prize may be awarded in the name of his/her parent or legal guardian who will be required to complete and sign any required documents. Failure to timely return any required executed documents may cause prize to be forfeited as solely determined by Infinity. Prize winner must claim or take delivery of the Prize within thirty (30) days of winning or the prize may be forfeited.

5. CONDITIONS:

- a. Payments of all federal, state, and local taxes are solely the responsibility of the winner. Winners will be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the Contest, winners agree to have their name, voice, and likeness used in any advertising or broadcasting material relating to this Contest (for the Station) without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent before delivery of the prize. Where legal, winners also agree to provide Infinity with an interview, which may be used in connection with the Contest.
- c. Contest winners and/or legal guardians will be required to sign a liability release prior to delivery of the prize. Pursuant to the liability release, winners will agree to hold Contest Entities and their officers, shareholders, directors, employees, agents and representatives harmless against any and all claims or liability arising directly or indirectly from the prize or Contest. By participating, Contest winners release the Contest Entities, and their agents, advertising and promotion agencies, affiliated companies, Contest partners and prize suppliers, and all of their respective affiliated companies, employees, officers, directors and shareholders, from and against all claims and damages arising in connection with each entrant's participation and/or entry in the Contest and/or their receipt or use of any prize awarded in this Contest. Prizes will be awarded "as is" and any and all warranties and/or guarantees are subject to the terms and conditions of the manufacturer and/or sponsor therefore, and winner agrees to look solely to such manufacturer and/or sponsor for any such warranty and/or guarantee. This Contest is governed by U.S. law and is subject to all federal, state and local laws. Void where prohibited by law.
- d. CBS Radio reserves the right to make changes in the rules of the Contest, including the substitution of a prize of equivalent value, which will become effective upon announcement.
- e. CBS Radio, in its sole discretion, reserves the right to reject entries from any domain or any email addresses and to disqualify any person or persons who CBS Radio believes is tampering with the entry process in any way, including but not limited to attempts to manipulate entry process in order to increase the odds of winning, any other fraudulent activity designed to affect the entry process or who is otherwise in violation of the rules or of any applicable law or regulation. CBS Radio further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned.
- f. Contestants understand, acknowledge and agree that CBS Radio shall not be liable for losses or injuries of any kind resulting from the rejection of an entry given CBS Radio's belief that the contestant was abusing or

- tampering with the Contest entry process in any manner or otherwise not in compliance with the rules or applicable law.
- g. The Station and CBS Radio are not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
 - h. Failure to comply with the Contest rules may result in a contestant's disqualification solely at the discretion of the Station or Infinity.
