



**MOViN 107.5's Man Candy Madness
OFFICIAL CONTEST RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1) HOW TO ENTER THE CONTEST:

- a. The MOViN 107.5's Man Candy Madness contest (the "Contest") will begin on or about February 11, 2008 at 12:00am Central Time ("CT") and will end on April 7, 2008 at 6pm CT.
- b. To participate, listeners must obtain and complete an official entry form on-line at www.MOViNdfw.com **click on the Man Candy Madness contest link and upload a head shot photo of themselves in a .jpeg format** with their first and last name, complete address, city, state and zip code, home telephone number, valid email address, and date of birth, as well as submit one (1) photo of themselves. Contestants will be required to agree to a photo submission release in order to submit their entry. Only one photograph per entry. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email addresses or the domain associated with the submitted email address. For purposes of these Official Rules, "receipt" of an online entry will be solely determined when the www.MOViNdfw.com web server records the entry information. Any automated computer receipt (such as one confirming deliver of email) does not constitute actual receipt of an entry for purposes of these Official Rules. KMKV's computer is the official time keeping device for this Contest. Use of any device to automate entry is prohibited. All entries must be received by **3/13/08 at 5:30pm CT**.
- c. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.
- d. Photographs must show the contestant only. No other person other than the contestant may be in the photograph. KMKV, at its sole discretion, reserves the right to disqualify and/or destroy any Photograph Entry if such Photograph Entry contains illegal, indecent, pornographic, sexually explicit content, or otherwise offensive material such as aberrational behavior, graphic violence or drug abuse, or if such Photograph Entry contains material whose content is deemed at the sole discretion of KMKV to be unsuitable for viewing or posting via the Internet. All Entries and their content become the property of KMKV and will not be returned.

2) ELIGIBILITY RESTRICTIONS:

- a. The Contest is open to all KMKV listeners who legally reside in the DFW Metropolitan area in the state of Texas and are 21 years of age or older. Employees of KMKV (the "Station"), CBS Radio, its corporate parent Viacom Inc., and its affiliates, their advertising agencies, participating sponsors/promotional partners, other radio stations in the DFW metropolitan area and the members of their immediate families and/or households are ineligible to participate or win. Subject to all applicable federal, state and local laws and regulations.
- b. Listeners are eligible to win a KMKV contest only once every sixty (60) calendar days. Listeners are eligible to win a prize valued at \$600.00 or more only once every six (6)

months. Only one (1) winner per household is permitted in any contest. This includes on-air contests and contests performed at a client's place of business.

- c. Winners must agree to be photographed and featured in the 2008 MOViN Man Candy Calendar or will forfeit their prize.
- d. Contestants are required to provide truthful information and the Station will reject and delete any entry it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3) PRIZES

- a. One (1) winner will receive \$1,000.00 in the form of a check. Approximate Retail Value **\$1,000.00**. Winner will be solely responsible for all taxes associated with the prize.
- b. All prizes or prize certificates may be picked up at the office of KMKV, 4131 N. Central Expressway Suite 1000 Dallas, TX 75204. The winner will forfeit any prize or prize certificate not claimed within forty-five (45) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. KMKV is not responsible for the safe arrival of a prize or prize certificate.
- c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsors may, at their sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) above and do not include taxes, gratuities, or any other expenses. Other restrictions may apply.

4) SELECTION OF WINNERS

- a. Decisions of the Station management with respect to the Contest are final.
The station staff will review all eligible entries received and randomly select sixteen (16) entrants and will post the 16 entries in a "bracket" by 3/17/08, which will be posted on the stations website on the Man Candy Madness page. In the event of a tie in ANY round, the station makes the final decision.
- b. . The photos of the 16 contestants will then be posted online on the station's website **on the Man Candy Madness page** beginning at 6:30am CT on March 17, 2008, to be entered into Round 1 of the competition. Once the photos are posted online, listener voting will begin. **Listeners will vote by selecting the individual they think looks the best from the 16 (The Sexy 16") entries randomly selected by the station. The top eight (8) individuals with the most number of votes, selected by the listeners, will advance to the next round (The "Hot 8"). The "Hot 8" will then be placed in a bracket by 3/24/08 and posted on the stations website on the Man Candy Madness page. Beginning at 6:30am on 3/24/08 and ending at 11:59pm on 3/26/08 listeners will be encouraged to vote on-line by selecting the individual they believe looks the best, from the 8 entries. The top four (4) individuals with the most number of votes will advance to the next round the "Foxy 4". The "Foxy 4" will then be placed in a bracket by 3/27/08 and placed on the stations website on the Man Candy Madness page. Beginning at 6:30am on 3/27/08 and ending at 11:59pm on 3/30/08 listeners will again be encouraged to vote on-line by selecting the 2 individuals they believe looks the best, from the 4 entries listed. The top two (2) individuals with the most number of votes will advance to the next round the "Finals". The "Finals" will then be placed in a bracket by 3/27/08 and posted on the stations website on the Man Candy Madness page. Beginning at 6:30am on 3/27/08 and ending at 11:59pm on 4/06/08 listeners will be encouraged to vote on-line by selecting the individual they believe looks the best, from the two (2) entries. At 6:30am on 4/07/08 the individual with the most number of votes from the "Finals" will be deemed the winner, upon confirmation of eligibility. Pending confirmation of eligibility, the contestant who is chosen as the winner will win one thousand dollars. Only one vote per person, per round please**

- c. Once listener voting has ended, station personnel will tally the votes in each round and the contestants that received the highest number of votes in each round will be deemed the winner(s) for that round. Should there be a tie among contestants in a specific category, **employees of KMKV will vote and the contestant with the highest number of votes will be deemed the winner(s).**
- d. The odds of winning depend in part on the number of entries received.
- e. Winners need not listen or be present to win.
- f. Winners will be notified via **telephone** on 4/7/08 at 6:30am CT. If a winner cannot be reached by **4/7/08 at 9:00am CT, the contestant with the next highest vote total will be deemed the winner.**

5) **CONDITIONS**

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners will be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the Contest, the winner(s) agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the Contest.
- d. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the Contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- g. The Station reserves the right to make changes in the rules of the Contest, including substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize related event is delayed, rescheduled, postponed, canceled or has a change of venue, the Station reserves the right, but not the obligation, to cancel or modify the Contest and shall not be required to award a substitute prize.
- h. Failure to comply with the Contest rules may result in a contestant's disqualification, solely at the discretion of the Station.
- i. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the Contest, or in the announcement of a prize.
